## ADDENDUM No. 1 to LETTER OF AGREEMENT dated 30 November 2016 BETWEEN

## THE CENTER FOR INTERNATIONAL FORESTRY RESEARCH (CIFOR) AND

## Politeknik Kementerian Kesehatan (Poltekes) Pontianak

CIFOR and Poltekes Pontianak have previously signed a Letter of Agreement (LoA) for From Growing Food to Growing Cash: Understanding the Drivers of Food Choice in the Context of Rapid Agrarian Change in Indonesia dated 30 November 2016, which expired on 30 June 2017.

CIFOR has agreed to amend the terms and conditions of the LoA as stipulated below:

- To extend the LoA until 28 February 2018 and provide additional fund of IDR 115.579.746 to complete the additional tasks (third round of survey) as described in Annex 1 attached into this Addendum;
- 2. To revise the first Paragraph of the LoA into the following: "The Center for International Forestry Research ("CIFOR"), in close collaboration with its partners, has submitted to the Drivers of Food Choice Competitive Grants Program funded by the Bill & Melinda Gates Foundation and the UK Department for International Development a proposal entitled, "From Growing Food to Growing Cash: Understanding the Drivers of Food Choice in the Context of Rapid Agarian Change in Indonesia". The proposal has now been accepted for funding through University of South Carolina, and CIFOR is pleased to grant to Poltekes Kementerian Kesehatan (Poltekes) Pontianak, Nutrition Department ("Subgrantee") the sum of IDR232,849,421 ("Subgrant Funds") in accordance with the Terms of reference attached in Annex 1 of this Letter of Agreement, Annex 1 of Addendum 1 ("Research Project") and following Terms and Conditions: "
