



MEMORANDUM OF UNDERSTANDING OF COOPERATION
between
University College of MAIWP International (UCMI)
and
Pontianak Health Polytechnic of Ministry of Health

In order to promote cooperation in Medical Science, Information Technology, teacher education, Management and Business exchanges and scientific research between **University College of MAIWP International (UCMI) and Pontianak Health Polytechnic of Ministry of Health** the following types of collaboration will be pursued:

- Exchange of students;
- Exchange of visiting research scholars;
- Joint (M.S./ Ph.D.) programs in the field of areas that suitable with the University College of MAIWP International (UCMI);
- Joint research projects in the field of areas that both University needs;
- Participation in international conferences, seminars, symposia, workshops and other activities agreed by both parties; and
- Exchange of academic materials and other information.

This Memorandum of Understanding expresses the intentions of the parties and places no financial obligations or supplementary funding commitments on either party. The terms of cooperation for each specific activity contemplated under this Memorandum of Understanding and Cooperation shall be mutually discussed and agreed upon by both parties prior to the initiation of that activity. Each institution shall designate a liaison office to develop and coordinate the specific activities agreed upon.

This Memorandum of Understanding will become effective upon the date of signature by both parties and shall remain valid for a period of five (5) years from the date of the last signature. The understanding may be modified by the written mutual consent of both parties. Either party may terminate it by giving the other party twelve months' written notice, unless an earlier termination is mutually agreed upon.

Each party shall make any public announcement or statement or publish or release any information in relation to any proposed activity or proposed collaboration without

the prior written approval of both parties. Each party shall keep confidential any information that it received from the other party which is marked confidential or which a party notifies the other party is confidential.

This Memorandum of Understanding is completed in English and is hereby signed in two (2) copies with one (1) copy remaining in the possession of each party.
